• Welcomed every one and presented the meeting agenda.

Brent Wheeler - Project Coordinator, Boulder County Parks & Open Space [7:03 - 7:35pm]

- Discussed project plans for the Niwot area:
 - Formalize social trail from Dry Creek loop trail behind NHS to Niwot Road, summer 2017
 - Formalize social trail that cuts through Left Hand Grange Park from LoBo trail to parking lot
 - Redesign Left Hand Grange Park trail head, parking area, bathrooms, and connection to Dry Creek trail across 83rd.
 - Will coordinate with 83rd culvert installation road work.
 - Parking lot will be a construction area for 4-6 months starting in June.
 - Contractor predicts completion by Oct, but has until Jan.
 - Will be looking for public volunteers to help with landscaping after construction is complete.
 - Improve trail road crossing:
 - Left Hand Grange Park to Dry Creek trail crossing 83rd
 - Dry Creek trail to Niwot Loop trail over Niwot Road at Niwot Hills entrance
 - (possible) Niwot loop trail crossing to Legend Ridge over Somerset Road Somerset HOA is currently blocking this effort
- Presented how the public can volunteer to help complete many of these projects
- Q & A
 - Road striping at trail road crossings
 - Traffic flows and juristictions will dictate
 - Flush toilet at Left Hand Grange Park, winter availability.
 - The requirement for a flush toilet (Left Hand Sanitation District) has already doubled the cost, so will need even more funds to pay for heater and heating.

• Garbage cans along Dry Creek trail, especially for dog poop
