## **County Actions**

- Road Maintenance The County is still working on this issue. They have mailed out postcards to residents and are taking a survey.
- **Niwot Park-** The NCA would like to offer to pay for the site plan review boulder county is requiring, estimated at \$500 \$600. Heidi to contact Biff.
- Sheriff Substation in Niwot Last communication stated they plan to move to the Mt View Fire Station and rent space at this location.
- 83<sup>rd</sup> Street Heidi reported that Boulder County held a meeting with a few residents living along 83<sup>rd</sup> street to discuss the speed control plans at 83<sup>rd</sup> and Niwot Meadow Farms entrance. Boulder County stated that they do not have enough space at this intersection to install a round-a-bout and instead are considering a raised crossing. Questions were raised as to why only a few residents were informed of the change in direction and why Niwot Meadow Farms residents were not included in this meeting.
