**Mountain View Fire Protection District:** Sheri Hannah-Ruh, MVFPD, reported on the proposed food drive for non-perishable items and monetary donations planned in July. The collection site of the Niwot Market was agreed to be most centrally located and the drive benefits would go to Community Food Share.

**Clean Up Day Summary:** Heidi reported that >200 Niwot families participated in the event and a wrap up news release with event photos will be sent to the Left Hand Courier.

**County Actions:**

- Road Maintenance - Don reported on the Boulder County unincorporated area survey and Neal addressed the issues / possible options that the Boulder County Commissioners face with this topic.
- Medical Marijuana - There is an open hearing Tuesday 08 June for the general public with the Boulder County Commissioners and there was a general discussion about residential concerns.

**Niwot High School Liaison Position on the NCA Board:** Motion was made, seconded, unanimous approval to add said position. NHS senior Carrie Struthers was nominated for this first position and approved.

**Niwot Nostalgia Days planning:** There was general discussion about all the work that needs to be organized: evening performers and stage contracts are signed with deposit, County application filed, applied for event insurance, theme, grand marshal, overall coordinator, booths, parade, traffic control, volunteers, Native American coordination, advertizing/posters/banner/notices, fund raising, logistics, pancake breakfast, how can NCA aid the Niwot business community and what other opportunities can be added to event.

**NCA Monthly Newsletter:** Renae provided status and asked that any news articles for June be submitted.

**Niwot Loop Trail:** Heidi provided update and area for probable trail development was discussed.

**Adjourned:** The meeting was adjourned by Neal at 9:00 PM.
