BoCo FIRM to appeal

After consultation with our attorney, Madeline Meacham of Halpern Meacham, BoCo FIRM's Steering Committee voted unanimously to appeal Judge Dave Williams's decision to dismiss the subdivision paving lawsuit filed against Boulder County.

Having defeated two County taxing schemes, the Public Improvement District and the Local Improvement District, BoCo FIRM filed an Amended Complaint on February 9, 2015, that alleged the County's actions to neglect our roads were arbitrary and unreasonable. The suit alleged that the County's failure to fund maintenance of subdivision paved roads was contrary to law, and was not based on lack of funds, as the County had repeatedly claimed, but was based on the County's unwillingness to follow state law because the County had different priorities. The County did not address the merits of our claims, and instead argued that we did not have standing to sue the County for failure to fund maintenance of a subset of paved county roads.

The Court stated in its ruling on the County's Motion to Dismiss that the over 300 plaintiffs did not have standing to sue the county. In addition the Court wrote that we could not establish a contractual basis for the suit and as a result dismissed our mandamus claim.

What we will appeal

BoCo FIRM attorney Madeline Meacham stated that "We are moving to file an appeal of the District Court's ruling with the Colorado Court of Appeals. We will appeal the Court's dismissal of our contract and mandamus claims as well as the Court's determination that we do not have standing to pursue this suit. If we prevail in the appeal, we will then have an opportunity to present to the Court the merits of our claims."

Why we are appealing

The BoCo FIRM Steering Committee reiterated that the filing of the appeal is consistent with our goal from day one; to get the subdivision roads fixed without the need for new taxes. We firmly believe that the County has sufficient funding to maintain our roads without the need to cut other county services. The injury we have suffered has been due to over twenty years of neglect by the County. It is especially egregious to now require those who have watched their roads deteriorate and property values diminish to pay extra because of the County's irresponsible and ongoing neglect. Maintaining public roads, including subdivision roads, is a core government responsibility and is recognized as such by being a statutory requirement. BoCo FIRM is firmly resolved to represent the interests of county residents in this ongoing battle with the County's Board of Commissioners.

Our responsibility

Finally, we strongly believe that if we do not pursue all legal options in this fight, we will abdicate our responsibilities as citizens. After all if a singled out class of offended taxpayers have no standing to address issues, what constraints are available to prevent elected officials from violating the laws, or to remedy such, regarding the misuse of taxpayer funds?

What else is BoCo FIRM doing on the paving issue?

In addition to spearheading the fund raising and coordination of the lawsuit, BoCo FIRM is also actively involved in the following activities.

Keeping neighborhood HOAs informed

Alleged fraud committed by the County Commissioners

BoCo FIRM has submitted a letter to Governor Hickenlooper regarding alleged fraud committed by the County. The fraud allegation centers on Highway Users Tax Fund reports the County is required to submit to the state. The alleged fraud concerns the County claiming in the reports that they are maintaining subdivision roads while simultaneously telling the courts in our lawsuits that they aren't maintaining these roads. By filing allegedly false reports, the County has received tens of millions of dollars in state funds that they may not be entitled to receive. Our work with the state on this issue is ongoing.

Political options

We are also beginning to examine what political options are available. If we choose to go this route, our goal would be to help elect Commissioners that would be committed to fixing our subdivision roads without new taxes. We would like to emphasize that as we are currently not a political committee prior to undertaking any political actions, we would need to restructure BoCo FIRM as an issue committee.
