# Question #4 Land Use / Planning Commission

Homeowners in rural Boulder County often complain that they do not have control to moderately improve their property and are subject to more regulation than city residents. Square footage limitations, neighborhood "character", and SMART regulations are used to deny building permits.

Case and point: a local resident with 2 acres claims to be limited 2,650 square feet for home, garage, AND outbuildings based on the median size of homes within a 1,500' radius.
